## Official Rules of Entry 2018 Honda Pilot EX-L Raffle

- The Volunteers of America Raffle is only open to legal US residents 21 years or older.
- A maximum of 1,500 entries will be sold at \$50 per ticket.
- The Volunteers of America Golfstar Classic Raffle Grand Prize will be a 2018 Honda Pilot EX-L from the Superior Honda Dealership.
- Only official and legible ticket entries containing the legible name, address and/or phone number of the entrant are eligible for the drawing. No facsimiles are permitted.
- Tickets may be purchased in the following manner:

  - > **In person:** Volunteers of America, 4152 Canal St., New Orleans, LA. Entries are accepted Monday-Friday 9:00 a.m. until 4:00 p.m.
  - > **At Volunteers of America sponsored events:** Carousel in the Park on Saturday, November 18, 2017, in front of the Hyatt Regency Hotel on December 3, 2017, immediately prior to the Saints game, at Ye Olde College Inn, on Tuesday, January 23, 2018, and at any and all other events held by Volunteers of America with regards to this raffle including but not limited to the Volunteers of America Golfstar Classic held on March 13, 2018.
- Winner will be determined in a random drawing to be held at the Volunteers of America Golfstar Classic on March 13, 2018, at 5:00 p.m.
- Winner need not be present to win and will be notified by phone if not present.
- **Winner must present a certified check currently estimated at \$7,300.00 based on current tax rates for income tax**, valid driver's license, and proof of vehicle insurance

card to the Volunteers of America office by the close of business on or before April 13, 2018, to receive the prize. Winner must also complete form W-9 and W-2G during the transaction. Income taxes are 25% of vehicle value minus the \$50 ticket wager.

- Winner has 30 days after claiming the prize with VOA to take delivery from Superior Honda. Winner will accept vehicle "as is" and is solely responsible for all taxes including federal, state, income taxes, sales taxes, registration, title and license fees, insurance and all other costs incurred in claiming, registering or using vehicle at delivery from Superior Honda.
- Three alternate names will be selected. Alternate, in the order selected, will be awarded the prize in the event the first winner does not comply with all rules enumerated herein and/or does not validly and/or timely claim the prize.
