- Tickets will be sold for \$20 for one, or \$50 for 3.

- Winner will be determined in a random drawing to be held at the Volunteers of America Golfstar Classic on March 12, 2018, at or before 5:00 p.m.

- Winner need not be present to win and will be notified by phone if not present.

The trip must be booked a minimum of 60 days in advance, and booking must take place within one year of winning, or on or before March 12, 2020.
